Our History

The origins of the Club date back to July 15, 1974, when the "Essex Rocket All Stars Hockey Club" was formed. The Club changed its name to the "New Jersey Rockets" on January 27, 1976, in conjunction with the move to the then new ice arena in Totowa. Beginning with the 1984-1985 season, the New Jersey Rockets and the New Jersey North Stars began a joint operation in the Totowa Ice Arena. On June 29, 1987, the New Jersey Rockets "merged" with the Essex County Chiefs. The Essex County Chiefs became inactive and the Club's name was changed to the "New Jersey Arrows Hockey Club."

In September of 1988, the Club obtained permission from the New Jersey Devils to use its National Hockey League name, logo and colors. As a result, the Club changed its name to the "New Jersey Devils Youth Hockey Club" on September 13, 1988. Beginning with the 1988-1989 Season, the Club skated all its teams using the New Jersey Devils name, logo and colors.

The Club has a proud tradition and takes pride in its years of excellence and accomplishments in all of its programs.

To ensure that teams are placed at the proper levels, the Devils reserve the right to adjust the teams we field and the levels played (AAA, AA, A & B) based on the actual numbers and skill levels of players who attend tryouts.
